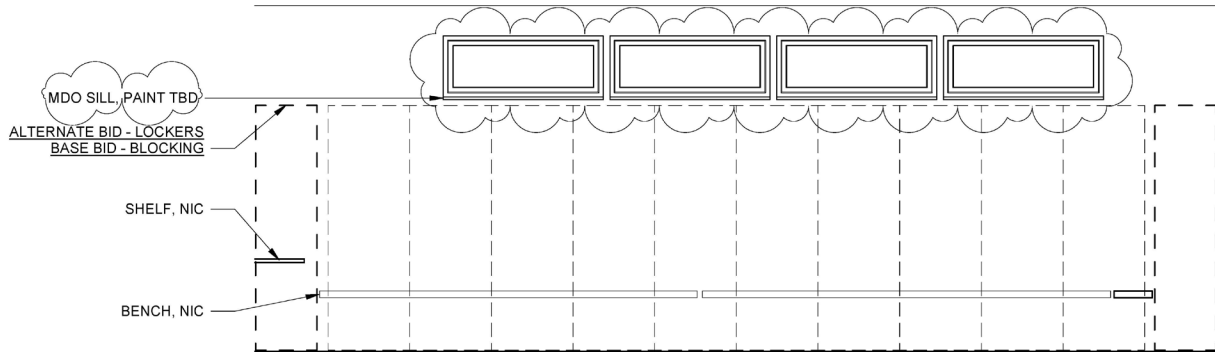
CHANGES TO DRAWINGS:

1. **Sheet A2.1 Floor Plans**
 - a. Fire Extinguisher Cabinets (FEC) shall be semi-recessed painted white. Fire Extinguisher by Owner.
 - b. Provide 2 coats concrete sealer on all exposed concrete floor surfaces: BASF Kure-N-Harden, or equal.
 - c. Wood columns to be 6 x 6.

2. **Sheet A5.2 Detail 1/A5.2**
 - a. Soffit Board to be Hardipanel or rough-sawn plywood no-plugs.

3. Sheet A6.1 Interior Elevations 1, 5 and 9

- a. Delete "1x3 WOOD TRIM" and "1x2 WOOD TRIM"
